This has been a long and difficult road to follow because of the power structures in the Institutions that decide what is acceptable and what is to be denied. While the censorship of the Inquisition was notorious, it still exists in all of the media in the United States.

In academia, schools of thought in the many disciplines become the modern censors as sensitive but revealing research is suppressed. Read the work of paleoanthropologists Cremo and Thompson in News and Bits. While our listings in the Pre-Columbian Series, the Mexican Series, and the Chicano/Chicana Series are adequate, we hope to add as we develop further, more listings to the Ancient Culture Series which includes cultures from the Jewish, Gypsy, Arab, Women, and Eastern sectors. We would be happy to peruse the works for possible inclusion to our website. We are preparing in final form some eight E books both of a critical and novelistic nature. While most of the E books are original and unpublished research, there will be some reprints made in the future of past works that are out of print. The predominant languages will be English and Spanish. The title should be a clue to the language used. Some will be translations as is the case with *The Cave of Naltzátlan*, a novel concerned with presenting the Aztec version of the “Conquest”; in it you learn about their unique philosophy and cosmology of the Confederation of Anahuac in addition to cultural time-space in Mexico and South Texas circa the forties. The Spanish language version went out of print shortly after its publication. At a later date, the E book reprint of the original Spanish version will be made available in view that it is rare to find a copy of this unique work. By becoming informed you will be able to answer the difficult questions. For example:

- Why after a century, is there still a migrant stream of Mexican-American workers?
- Why is it not known in textbooks, Hollywood and/or the media that a large percentage of Mexicans and Blacks drove the cattle drives to Kansas?
- What was the first Civil Rights Movement in Texas for its Spanish-Speaking citizens? Who was the first woman activist in this effort?
- What is the origin of the Virgin of Guadalupe prior to the discovery of the Americas?
- Who was Juan Nepomuceno Cortina? How does he figure in Texas history?
- What Mexican woman was known as the Angel of Goliad? Connection to Texas troops?
- What woman was a force behind the efforts of Cesar Chavez’ Farm Worker Movement?
- What is the correlation between the Christian Crusades and the Spanish Conquest?
- In terms of religious and deleterious propaganda ploys by the Spanish, what experience did Jews and Native Americans share in common?
- What are the connections between September 11 and the Middle Ages? What is the origin of the jihad? Who invented religious wars during the Middle Ages?
- What are the autochthonous philosophical and metaphysical factors that contradict colonial myths of Native peoples created by the Spanish?
- How was the role of women in pre-Columbian Society different from her Western counterpart?
- What is the connection between Native “religion” and Astronomy and Mathematics?
